Surfactant polymers designed to ensure lateral movement of water, rapid rewetting, and uniformity of moisture are combined with penetrating surfactants. This combination is designed to deliver a firm, dry playing surface while maintaining optimal overall soil moisture conditions. Cation sequestering polymers are added to condition the water and limit cation interaction with spray tank mixes.

HYDRA-FIRM

GENERAL INFORMATION: HYDRA-FIRM is a combination of best-in-class soil surfactants combined with penetrants and cation sequestering polymers. Hydra-Firm is designed to ensure uniform moisture characteristics while pushing excess water out of the soil profile, resulting a uniformly moist, rapidly rewetting, yet firm turf surface. Cation sequestering polymers assist in conditioning spray tank solutions.

DIRECTIONS FOR USE: Apply 4-6 ounces per 1,000 square feet every 30 days. Lightly irrigate the product into the soil profile for best results. Start with an initial rate of 6 ounces per 1,000 square feet and then reduce rates as needed for maintenance.

Tank Mixing: HYDRA-FIRM may be tank mixed with other commonly used turf chemicals and fertilizers at rates not to exceed 6 oz per 1000 sq. ft. If applicator is unfamiliar with the performance of this product in tank mixes under user's growing conditions, HYDRA-FIRM should be tested prior to large-scale application. The applicator should always exercise judgment and caution when using this and all other turf products. Always conduct a jar test when tank mixing HYDRA-FIRM with other inputs when the compatibility is unknown.

PRECAUTIONARY STATEMENTS: Do not get in eyes or on clothing. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet. Remove and wash contaminated clothing before reuse. **Personal Protective Equipment:** Wear chemical resistant gloves, Long-sleeved shirt and long pants, and shoes plus socks.

FIRST AID: Call a poison control center or doctor immediately for treatment advice. Have the product container with you when calling a poison control center or doctor, or going for treatment. **If Swallowed:** Have person sip a glass of water if able to swallow. STORAGE: Store in a cool, dry place. Store in original container only. Do not add anything to the container. Keep container tightly sealed when not in use. Do not store near fire, flame or other potential sources of ignition. **DISPOSAL:** Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best method of disposing containers if allowed by law. The Agriculture Recycling Container Counsel (ACRC) operates the national recycling center program.
