GENERAL INFORMATION: HYDRA-STIK is a superior spreader sticker designed from organosilicon and a proprietary latex-based sticking agent. Rain fast in 30 minutes, HYDRA-STIK enhances the deposition and spreading while creating a protective film to reduce run-off and protect pesticides from loss.

DIRECTIONS FOR USE: Unlike other products, HYDRA-STIK requires higher usage rates for low volume spray applications than what is required for higher volume sprays. For spray volumes above 50 gallons per acre, apply 8-16 ounces per 100 gallons. For spray volumes of 10 to 50 gallons per acre, apply 16-24 ounces per 100 gallons. For ultra-low spray volumes below 10 gallons per acre, apply 24-32 ounces per acre. **Tank Mixing:** Shake well before using. HYDRA-STIK may be tank mixed with other commonly used turf chemicals and fertilizers. If applicator is unfamiliar with the performance of this product in tank mixes under user's growing conditions, HYDRA-STIK should be tested prior to large-scale application. The applicator should always exercise judgment and caution when using this and all other turf products. Always conduct a jar test when tank mixing HYDRA-STIK with other inputs when the compatibility is unknown. Always follow the label directions of any pest control product, to include the recommendation on the use of an adjuvant.

PRECAUTIONARY STATEMENTS: Do not get in eyes or on clothing. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet. Remove and wash contaminated clothing before reuse. **Personal Protective Equipment:** Wear chemical resistant gloves, Long-sleeved shirt and long pants, and shoes plus socks.

FIRST AID: Call a poison control center or doctor immediately for treatment advice. Have the product container with you when calling a poison control center or doctor, when going for treatment. **If Swallowed:** Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person. **If on Skin or Clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. **If inhaled:** Move person to

fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferable mouth to mouth if possible. **If in Eyes:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses if present, after the first 5 minutes, then continue to rinse eyes.

STORAGE: Store in a cool, dry place. Store in original container only. Do not add anything to the container. Keep container tightly sealed when not in use. Do not store near fire, flame or other potential sources of ignition. **DISPOSAL:** Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best method of disposing containers if allowed by law. The Agriculture Recycling Container Counsel (ACRC) operates the national recycling center program.
