**Use Rates:** 3 oz. per 2 gal. of water. Adjust with water or product, if needed, to achieve desired foaming characteristics.

**PRECAUTIONARY STATEMENTS:** Do not get in eyes or on clothing. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet. Remove and wash contaminated clothing before reuse. Personal Protective Equipment: Wear chemical resistant gloves, Long-sleeved shirt and long pants, and shoes plus socks.

**FIRST AID:** Call a poison control center or doctor immediately for treatment advice. Have the product container with you when calling a poison control center or doctor, or going for treatment. If in Eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses if present, after the first 5 minutes, then continue to rinse eyes.

**STORAGE:** Store in a cool, dry place. Store in original container only. Do not add anything to the container. Keep container tightly sealed when not in use. Do not store near fire, flame or other potential sources of ignition. **DISPOSAL:** Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best method of disposing containers if allowed by law. The Agriculture Recycling Container Counsel (ACRC) operates the national recycling center program.
